Guidance for C&L notification under CLP

Version 8 December 2010

Steps:

1. Obtain the C&L proposal from the PMC secretariat
2. Login to your REACH-IT account or create a REACH-IT account
3. Choose your notification type (Online, via IUCLID 5 or via Bulk submission)
4. Submit your notification or accept an existing notification
5. Implement the applicable classification, labelling and packing requirements

STEP 1: OBTAIN THE C&L PROPOSAL FROM THE PMC SECRETARIAT

Notifiers will need to know which is the final classification proposal agreed by PMC Members for each relevant substance and intermediate. This final classification proposal shall consider available and generated data (for physico-chemical properties and other endpoints where relevant) as well as expert judgement of PMC Members (cf. outcome of PMC *ad hoc* CLP meetings, Brussels, 1-3 December 2010).


PMC secretariat will provide a matrix containing all CLP classifications for all substances and intermediates that are part of PMC's REACH projects and which require a CLP notification. These matrices will only contain the classification result and will not provide details on the applicable signal word, hazard pictograms and precautionary statements. These will be provided in a separate document (IUCLID 5 extract).

These matrices aim at guiding lead notifiers in the preparation of the CLP notifications. Notifiers may also use these matrices to identify the classification proposal they have to select and agree with on REACH-IT, in the event several classifications exist or have been submitted for a given substance or intermediate.


STEP 2: LOGIN OR CREATE REACH-IT ACCOUNT

If you already have a REACH-IT account, click on “login” on the screen below. If not, click on “Sign up as a company”:

Once your REACH-IT account is created, you may login to proceed with your CLP notification(s).

STEP 3: CHOOSE YOUR NOTIFICATION TYPE

Once in your REACH-IT account, you may submit a C&L notification by clicking on either "Registration/notification" or "Classification and Labelling" in the vertical menu on the left hand of the screen.

The first option only allows you to submit an IUCLID 5 type of CLP notification (only recommended for substances having more than one classification). The second option allows you to choose one of three submission options:

- Notify a C&L online
- Notify a C&L using IUCLID
- Notify a bulk C&L

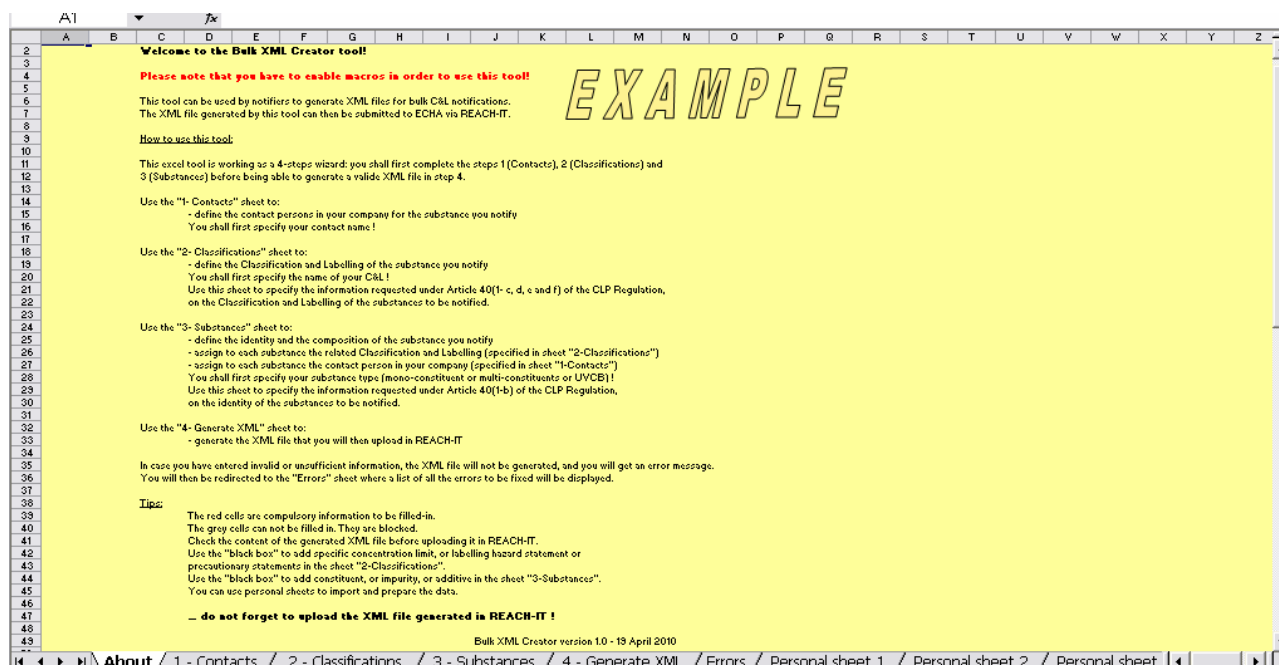

When you click on "Download the C&L Bulk XML creator tool for Excel 2003 and 2007" please follow the subsequent steps to ensure a proper installation of this software on your computer (this may take several minutes). Once the download of the .zip file is completed, you may take a look at the example provided by ECHA (CLNotification-example_EN.xls):



The example file aims at showing the steps (one step per tab or worksheet) to be followed to prepare a Bulk C&L notification starting with a Contact tab, following which the classifications can be entered for each substance. When generating the XML file, if you have entered invalid or insufficient information, the XML file will not be generated and instead, you will get an error message.

Once you are acquainted with the example file, you may start preparing your Bulk C&L notification by using the virgin template (CLNotification1.2.xls). Scroll-down menus are provided to facilitate the completion of each worksheet. Make sure you keep track of the classification name you provide for each substance as this classification name acts as a reference to link the proper substance with the proper classification. Only a few print screens are provided on this route in this document. Please refer to ECHA's Guidance instead: http://echa.europa.eu/clp/inventory_notification/notification_how_en.asp.

Co-notifiers are invited to use the online tool to accept an existing notification (whether an existing Annex VI of CLP classification or a classification submitted by a Lead notifier). This route is explained below.

The IUCLID 5 tool is only recommended to submit CLP notifications for substances requiring more than one classification. In this case the IUCLID 5 file is prepared by the PMC secretariat and the consultants, and further completed and submitted by the Lead notifier, as done for REACH Registrations too.

STEP 4: SUBMIT YOUR NOTIFICATION OR ACCEPT AN EXISTING NOTIFICATION

BULK NOTIFICATION





STEP 5: IMPLEMENT THE APPLICABLE CLASSIFICATION, LABELLING AND PACKAGING REQUIREMENTS

As indicated above the CLP matrices will only contain the resulting classification but will not contain the applicable Signal words, Hazard pictograms and Precautionary statements. Moreover, only the CLP classification will be provided in these matrices.

In order to enable Lead notifiers to submit a complete CLP notification and allow all notifiers to implement the notified classification and associated labelling and packaging requirements as required under CLP/GHS and DSD (necessary during the transition period of January 2011- June 2015), IUCLID 5 extracts will be generated (similar to the output of REACH Chemical Safety Reports) and circulated to all Members.

Each legal entity is responsible for implementing the notified classification. This means:

- Creating or updating the existing Safety Data Sheet (SDS)
- (Re-)labelling of substances and mixtures
- (Re-)packaging of substances and mixtures.

The above is necessary to properly implement the CLP regulation requirements as well as to duly inform your downstream users and customers.
