An impurity is an unintended constituent present in a substance, as produced. It may originate from the starting materials or be the result of secondary or incomplete reactions during the production process. While impurities are present in the final substance, they were not intentionally added.

§ Concentration ranges define the substance sameness criteria agreed by all EPMF Members in preparation of the communication with other SIEF members.

§§ Typical concentration refers to the representative sample used for testing.

§ Corresponds to 20,7–20,9 % Rh.

The composition given above is typical and should therefore represent the majority of Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium as manufactured and/or imported in the EEA market. Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium containing less than 93,2 % Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium may still be considered to be the same for the purpose of registration under REACH and may be referred to as impure Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium to distinguish it from the typically pure Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium.

* Crystalline form: solid material whose constituent atoms, molecules, or ions are arranged in an ordered pattern extending in all three spatial dimensions. Amorphous form: solid material whose constituent atoms, molecules, or ions are randomly arranged.

** Nanoform: particles in the size range 1 - 100 nm (for full definition of a nanomaterial, see <http://ec.europa.eu/environment/chemicals/nanotech/index.htm#definition>). Fine powder: particles in the size range 100 – 2.500 nm. Coarse powder: particles in the size range 2.500 nm – 1 mm. Massive object: particles in the size range > 1 mm.

Hydrolysis: decomposition (cleavage of chemical bonds) by the addition of water.

§ Hygroscopic substance: readily attracts moisture from its surroundings in open air, through either absorption or adsorption. Cf. also water/moisture content in Table 4.

Umicore (Belgium) is the Lead Registrant for Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium. The EPMF will provide support to the Lead Registrant as laid down in the EPMF Agreement.

9. REACH Strategy

The table below presents the overall Registration Strategy for Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium based on the information available to the EPMF by the date given above on the document.

The Registration Dossier will be prepared for the highest substance status (information requirements associated to a substance or Article 10 Registration being higher than an intermediate handled under strictly controlled conditions or Article 17 or 18 one) and associated tonnage band.

The recap below therefore reflects the scope of work of the EPMF for Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium and sets the minimum and maximum set of information that will be gathered and/or produced when preparing the Registration Dossier for Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium as described in this ID Card.



If higher information requirements are necessary, these can be included in the Registration dossier (if EPMF is made aware of these additional requirements in-time) as an update to the already submitted dossier.

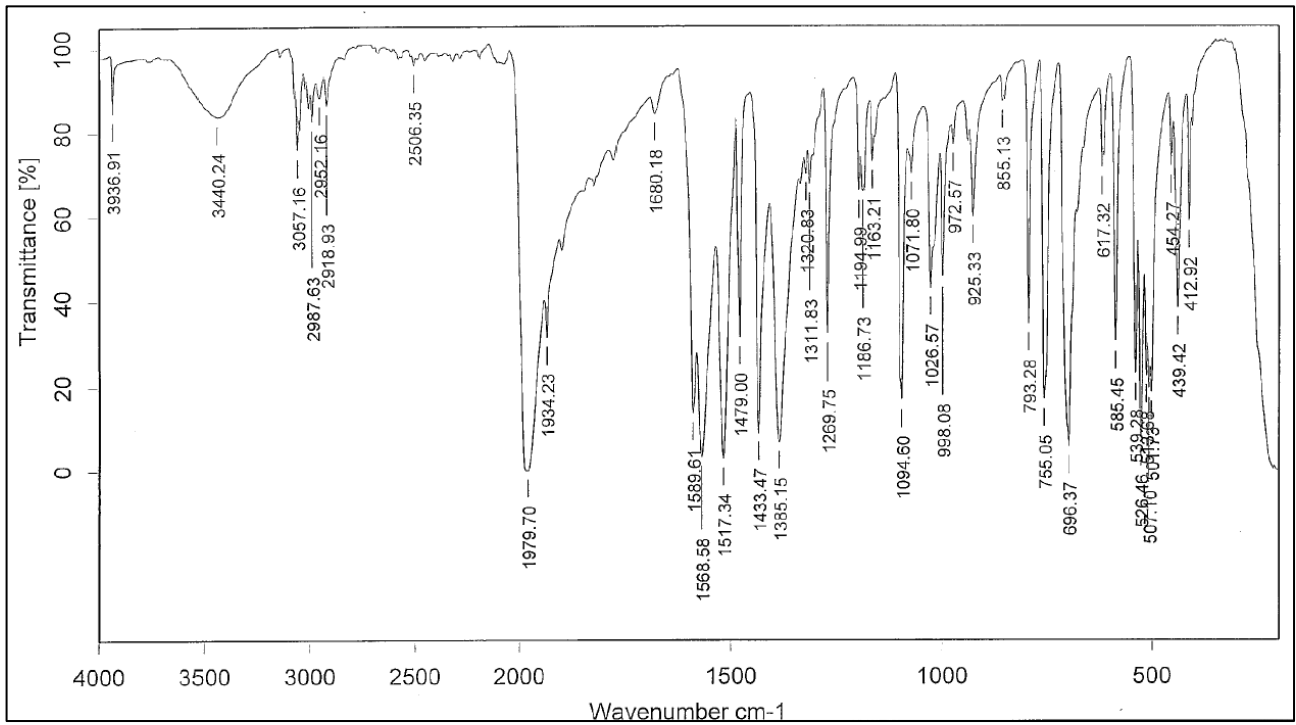


Figure 1. IR spectrum of Carbonyl(pentane-2,4-dionato-O,O')(triphenylphosphine)rhodium
